## **REQUEST UNDER ENVIRONMENTAL INFORMATION (SCOTLAND) REGULATIONS 2004**

I refer to your request for information, received by email on 19<sup>th</sup> November 2016.

We have applied the exemption under Section 39(2) of the Freedom of Information (Scotland) Act 2002 as we have determined that the information sought in your request is environmental information. We are therefore handling your request under the terms of the Environmental Information (Scotland) Regulations 2004 (EIRs). In this case the public interest in maintaining this exemption and in dealing with the request in line with the requirements of the EIRs outweighs any public interest in disclosing the information under FOISA.

Your specific requests and the response from the National Park Authority are provided below.

# "15 September 2014 Map Loch Voil what is the meaning/definition/significance of the two large black and three large yellow dots."

The yellow and dark green dots, which appear on this slide, are part of the background layers of mapping used and were not of any relevance to the content of the PowerPoint presentation. The slide was used to give a visual example of how a camping management zone was mapped. This slide is now out of date.

## "16th March 2015 Slide 30 what is the meaning of shoulder day".

The term 'shoulder day' is used to identify the days at the beginning of March and end of October, at each end of the main visitor season.

"16th March Slide 30: please provide me with any written information the Park holds about how it came up with the maximum permits available for peak weekends, standard weekends/peak weekday, ordinary weekday and shoulder day."

Under R10(4)(c) of the EIRs, we have to advise that it has not been possible to identify relevant information to answer this request, as it is formulated in too general a manner.

In order to comply with our duty to advise and assist under R9 of the EIRs, we can advise that the information contained within the slides from the 16<sup>th</sup> March formed part of early thinking about how permits could be allocated and to what volume. This slide is now out of date.
