Hi Catherine,

Thanks very much for that. We had the roof colour as red as this is what was in the original planning application. We would be happy to move to grey. I have asked the landowner for his approval for this and await his reply.

The finishes for the intakes are to be as finished concrete for the structures. Bank re-enforcement work will be stone. I attach photos of similar intakes for your information. DSF6771 is similar to the main intake at Ledcharrie. DFS6355 is similar to the secondary intakes. As you know both of the intakes at Ledcharrie are in quite secluded location and so will not be visible until quite close to them.

I hope that this is sufficient for you and that we get the landowner's agreement to a grey roof. I hope to be in touch to confirm this very soon.

Thank you for submitting the revised powerhouse drawing ref 1830042RevA with the finishing details. The LLTNP landscape adviser responded as follows:

I have checked the drawing and the materials are;

Door – steel clad timber – iron grey

*Roof – steel cladding – dark red

Walls – roughcast

Louvres – grey aluminium

Transformer – olive green

*The only one I have concerns about is the Dark red colour as this does not seem to relate to any other building in the area particularly Ledharrie farm and outbuildings, though the powerhouse is not adjacent to it.

I would recommend a Slate grey roof as per images in LVIA.

Please can you advise whether you can change the colour?

Also please note that in order to discharge this condition details of the finishes for the intakes should also be submitted for approval.
