Before we issue a Restock Direction I would be grateful if you could discuss with your colleagues what an appropriate plan of action for the site would be. I am keen to get the branches and timber tidied up, but see no reason to remove from site as machinery may cause disturbance and damage. While the site may coppice, I also think that we should be pushing for some planting especially oak as there are very few on site and in theory there should be more, but it will be getting the right provenance. That's the basics but keen to have a NP input in to this.

Given what has happened here, we will also get the burden of a restock direction recorded in Registers of Scotland.

Further to our recent communications I confirm that XXXXXX visited site last Friday and reported to me on Monday. Following this consultation I decided it important that I also visit site to assess the impact on the owners future proposals.

- 1. The extent of works undertaken have come as a complete shock to the owners. The work was intended to simply allow access to survey the site for access by foot. This should have been described as "brashing access routes"
- 2. The work has been very poorly carried out because the trees have simply been felled and left lying with no attempt to create clear underfoot conditions. This was not what was intended. No felling was intended.
- 3. The owners were having the Walled Garden at Baronald House in South Lanarkshire cleared of self seeded whips, shrubs and trees as enabling works for development. This had been organised by XXXXXXX on behalf of the owners. XXXXXX who had been involved in the acquisition at Ardlui and instructed the site labour to 'clear access' at Ardlui. When XXXXXX attended site and viewed what was happening he stopped works immediately otherwise the entire site would have been cleared.
- 4. The work was MOST definitely not intended to facilitate building works. The site has been acquired with the intention of developing Chalets and Tree Houses on approximately 6 acres at the North end of the site with raised walkways through the trees intertwined over the wet-land. The attraction of the site from a development perspective is the woodland and wetland character. The plan is for a substantial economic investment at the North end of Loch Lomond on this site. The EIA scoping is programmed to commence this Spring and the intention is to submit a Pre-Planning Application to the NPA by early summer and a full Planning Application sometime thereafter subject to the usual scope and scale of environmental and economic supporting documentation.
- 5. There has been a complete failure of communication between the owner's agent, XXXXX and the labour. The agent's lack of familiarity with the site ensured that he was unable to be clear in describing what he wanted. There was a lack of any clear plan or properly specified contract.
- 6. The owner and agent are hugely embarrassed and apologise unreservedly.
- 7. In order to retrieve the situation the owner will employ a properly qualified woodland advisor and seek the advice of the LLTNP ecologist and other officials to determine whether there can be any environmental benefit from this activity ie the creation of sunny glades for invertebrates, improved public access? whilst ensuring that the area regenerates naturally. The owner will ensure guidance is followed which will possibly involve stacking the felled brash/trees in small piles to allow vegetation on the woodland floor to recover. Whilst not intended this bit of woodland has effectively been "coppiced" which is a recognised management tool and creates open glades which will be good for flowering plants and insects whilst the woodland grows back

from the cut stumps. In the first instance the owner intends to dear fence the entire site to promote regeneration.

8. The owner fully accepts that they are the liable party, and the agent fully accepts the blame for failing to properly instruct the contractor or seek the nuanced advice he would have received from his consultants.

I visited the site this morning.

I was shocked at the devastation. The whole centre of the wood all the way from south to north has been felled, including between the two streams to the north. This was a particularly fine native woodland comprising alder, birch, willow and some oak.

Most trees are over 100mm minimum diameter required for a Felling Permission licence. So I would imagine Scottish Forestry will be rather upset to say the least.

It would take a good few hours to count all the felled trees and require two people, as it is dangerous clambering over felled trees often over very wet ground. There are hundreds of trees, possibly as many as 500-700.
