The Loch Lomond & Trossachs National Park Authority – is there anybody there for outdoor recreation?

### Description

Most people I know who are working at home are getting more work done there than if they had the distractions of the office. This has also been claimed in the press to be the case. But in the Loch Lomond and Trossachs National Park Authority (LLTNPA) it appears that during the Covid crisis much of the managerial type office/paperwork has fallen even further behind schedule, been postponed or cancelled. Here I take a look at Outdoor Recreation which should have been given greater priority than ever before.

### The replacement for the Outdoor Recreation Plan (ORP) 2013 – 17

On 17 June 2013 the National Park Authority Board approved the Outdoor Recrea Lomond & The Trossachs National Park The plan outlines commitment to actions which enhance outdoor recreation opportunities across the Park from 2013 to 20 been developed in conjunction with a variety of stakeholders.

The new plan, named *"Active Park, Healthy People: Outdoor Recreation Delivery Plan"* (revised after 'Consultation') was meant to be presented to the NPA Board last year but wasn't.

This Board Meeting also considered the final Report on the Annual Operational Plan 2019/20 which stated:

L. Revised Outdoor Recreation Plan, consultation and finalisation Final draft document and launch delayed COVID-19 implications.

That takes us to the December 2020 meeting, just three months later, where it was reported that the ORP had been postponed to June 2021, i.e. 2021/22!

# Meantime the recreational soundbites and failures continue

Gordon Watson the Chief Executive of the LLTNPA was quoted in the Helensburgh Advertiser (Jan 14 2021) :-

Gordon Watson, the National Park's chief executive, said: "While it hasn't been the start to the new year that we had hoped for with another national lockdown, we must all do our bit to help stop the spread of the virus by staying at home and staying as local as possible.

"Getting outside into nature and exercising is going to be important for everyone's health and wellbeing particularly during the winter so we know that people living in and close to the National Park will be keen to enjoy the park where they are allowed to within the guidelines.

"This includes only going out with one other person or meeting up with one other person from another household and staying in your local area.

"Our car parks and toilets remain open, on winter operating hours, to support people to do this responsibly."

The evidence from Loch Lubnaig and Rowardennan (see here) shows otherwise.

The claims of Forest and land Scotland (FLS), who were also reported in the Helensburgh Advertiser Jan 14 2021, are more credible:

# Forest walk routes stay open

FORESTRY and Land Scotland's walking and mountain biking trails in Helensburgh and Lomond will remain open for local access under Scotland's latest lockdown limits.

The agency says it wants to help members of the public maintain mental and physical health and wellbeing alongside efforts to slow the transmission of Covid-19. The FLS trails in the Argyll Forest,

including those at Arrochar,

Ardgartan and Cruach Tairbeirt, will remain available for members of the public living locally. Simon Hodgson, the FLS chief executive, said: "We understand that there will be instances where young children, older people and less able people will not be able to manage

that short walk to their local woods, so we have kept our car parks open to help give them as much opportunity as we can."

While access rights have never been suspended at any time during the Covid crisis at least FLS does not appear to be putting barriers in the way of enjoying the countryside, unlike the LLTNPA with its locked toilets and car parks.
