I refer to your email and plans received on 18.02.2016 in respect of the above development.

The non-material variation requested is:

- Omit footbridge adjacent to proposed dam
- Amend design of proposed water intake from side entry intake weir with integral trash rack to a downstream front of dam intake with Coanda screen and associated fish friendly measures to conform with SEPA requirements
- Minor changes to penstock at turbine house, thrust block relocated and final details added.
- Powerhouse Elevations minor changes

I confirm that the revisions illustrated on the plan listed below are approved as a non material variation to application referenced 2013/0267/DET, subject in all other respects to the conditions of this permission dated 16.12.2014.

Reason for Decision:

The proposed variation is considered to be 'non-material' under s64 of The Town and Country Planning (Scotland) Act 1997 because an intake at this location has already been assessed as part of the original planning application and the change of orientation and design is considered to have ecological benefits and no additional adverse visual impact.
