3.2 Land Use

3.2.1 – Whole farm plans – New whole farm plans are now under development with Benmore Farm and Protnellan. The NPA have appointed a contractor to provide renewables advice to farm businesses who wish to diversify.

3.2 Land Use

3.2.1 Whole farm plans – The first two whole farm plans for Inverlochlarig and Loch Dochart have been produced. The process for writing the plans is being reviewed to continue to improve its efficiency and the overall effectiveness of the plans. Consultancy support to address revenue opportunities from tourism and outdoor recreation has been added to the suite of specialisms contributing to the plans. Further whole farm plans are on the horizon but the programme is not yet being promoted widely until the staff resource input required has been fully assess in the light of the first plans.

3.7 Whole Farm and Whole Estate Plans

The aim of Whole Farm/Estate Plans is to assess options and agree actions to improve the financial and environmental sustainability of land-based businesses in order to secure the benefits of positive land management that contributes to achievement of the statutory aims of the National Park. Subject to each business 'priorities, Plans aim to be holistic and integrated, covering business arrangements, agriculture, woodland and forestry, sporting interests, environmental issues and diversification opportunities. Each Plan sets a 25 year vision for the business and shorter term objectives, delivery of which can form the basis of an on-going, collaborated relationship with the NPS.

Work is on-going to progress the four current Whole Farm/ Estate Plans. No New Plans are being taken on until the current raft are complete and the vacant Land Management Adviser post has been filled – this post is currently being advertised and interviews are scheduled for 24 September.

Interest in the project remains high from land managers and representative bodies such as NFUS and Land and Estates. Scottish Government have also expressed interest, in the context of potential methods for delivering advice to land managers under the next Scotland Rural Development Programme.
