Yes I was aware of that but needed to ask the question whether there was an option. It did and still does appear not in the plans to use the ciste area other than the car park as an overflow hence my interest. It's a shame it can't be run as two separate areas. I was obviously aware of the lease but not the terms of the lease and understand up to a point the situation at Cairngorm. It would appear however that people have forgotten the lack of investment from previous tenants which may or may not be due to poor conditions for a decade in the 2000s. It would also appear an easy option to blame the current tenants and therefore HIE for everything but in reality it's Scottish snow sports and conditions are unpredictable.

Since my previous email I note HIEs announcement of their vision for the future and the likely investment of public money to be attributed to this vision.

Whilst not agreeing entirely with the proposal as it stands at the minute I would agree that the investment has to be made but I believe it must be thought of more as a subsidy for Scottish tourism to attract clients back to the area and encourage new clients to visit rather than an investment in snow sports. The best ski area in the world could not survive under Scottish conditions.

Thank you for your kind reply. I will watch with interest how the vision comes to fruition.
